Aims of the study: Patient comprehension is a critical part of meeting medical ethics standards of informed consent in study designs. The aim of the study was to determine if sufficient literature exists to require clinicians to disclose the specific risk that COVID-19 vaccines could worsen disease upon exposure to challenge or circulating virus.

Methods used to conduct the study: Published literature was reviewed to identify preclinical and clinical evidence that COVID-19 vaccines could worsen disease upon exposure to challenge or circulating virus. Clinical trial protocols for COVID-19 vaccines were reviewed to determine if risks were properly disclosed.

Results of the study: COVID-19 vaccines designed to elicit neutralising antibodies may sensitise vaccine recipients to more severe disease than if they were not vaccinated.

Vaccines for SARS, MERS and RSV have never been approved, and the data generated in the development and testing of these vaccines suggest a serious mechanistic concern: that vaccines designed empirically using the traditional approach (consisting of the unmodified or minimally modified coronavirus viral spike to elicit neutralising antibodies), be they composed of protein, viral vector, DNA or RNA and irrespective of delivery method, may worsen COVID-19 disease via antibody-dependent enhancement (ADE). This risk is sufficiently obscured in clinical trial protocols and consent forms for ongoing COVID-19 vaccine trials that adequate patient comprehension of this risk is unlikely

to occur, obviating truly informed consent by subjects in these trials.

Conclusions drawn from the study and clinical implications: The specific and

Conclusions drawn from the study and clinical implications: The specific and significant COVID-19 risk of ADE should have been and should be prominently and independently disclosed to research subjects currently in vaccine trials, as well as those being recruited for the trials and future patients after vaccine approval, in order to meet the medical ethics standard of patient comprehension for informed

The agency has long been criticized as too ponderous, focusing on collection and analysis of data but not acting quickly against new health threats. Public unhappiness with the agency grew dramatically during the COVID-19 pandemic. "We saw during COVID that CDC's structures, frankly, weren't designed to take in information, digest it and disseminate it to the public at the speed necessary," said Jason Schwartz, a health policy researcher at the Yale School of Public Health.

Privacy is a natural right because there are aspects of human existence and personal behavior that are not subject to the government. Natural rights come from our humanity. The government claims it can examine your emails, bank accounts, medical and legal records at will merely because it claims you have waived your interest in them by placing them in the custody of others. 

An Italian man has been diagnosed with HIV, Covid-19, and monkeypox simultaneously – the first known case of the concurrence of these three viral diseases, the Journal of Infection has reported.

According to an article published by the medical outlet last Friday, the 36-year-old male spent five days in Spain in June this year, developing a fever accompanied by a sore throat, fatigue, and a headache nine days later. A subsequent test yielded a positive result for Covid-19. To make matters worse, a rash appeared on the patient's left arm soon thereafter, with small, painful vesicles spreading across the man's body in the following days.

The man sought medical help and was hospitalized in an infectious diseases unit. The patient told doctors that he had had "condomless intercourse with men" during his sojourn in Spain.

Taking into account the appearance of pustules indicative of monkeypox, samples of the liquid contained in the vesicles were sent to be tested for the virus and came back positive as well.

The authors of a new review of the drug acetaminophen (paracetamol), sold under the brand names Tylenol and Panadol, are sounding the alarm about the use of the drug in infants and children, citing the drug's association with autism spectrum disorder (ASD).

"Our study shows that acetaminophen would never be approved for pediatric use by today's regulatory standards," Dr. William Parker, of WPLab, Inc., who led the research team that conducted the review on acetaminophen and autism, told The Defender.

The review, published in the July issue of Minerva Pediatrics, offers 17 lines of evidence that the commonly used remedy for pain and fever may be contributing to the autism epidemic.

The authors said their findings could have huge implications for preventing ASD, as acetaminophen is used so much in young children — in some populations, up to 90% of children receive acetaminophen in their early years.

The rate of ASD has skyrocketed in the last 40 years, and now affects 1 in 40 U.S. children. Acetaminophen became the drug of choice to treat fevers and pain in children in the early 1980s, after aspirin was associated with Reye's syndrome.

However, the use of acetaminophen in infants and children was never shown to be safe for neurodevelopment.

The resolutions conclude:

An executive, consisting of a governor-general, and such persons as may from time to time be appointed as his advisers, such persons sitting in Parliament, and whose term of office shall depend upon their possessing the confidence of the house of representatives expressed by the support of the majority.

What is meant by that is simply to call into existence a ministry to conduct the affairs of the new nation as similar as it can be to the ministry of England-a body of constitutional advisers who shall stand as nearly as possible in the same relation to the representative of the Crown here [start page 27] a her Majesty's imperial advisers stand is relation to the Crown directly. These, then, are the principles which my resolutions seek to lay down as a foundation, as I have already stated, for the new super structure, my object being to invite other gentlemen to work upon this foundation so as to best advance the ends we have in view.
